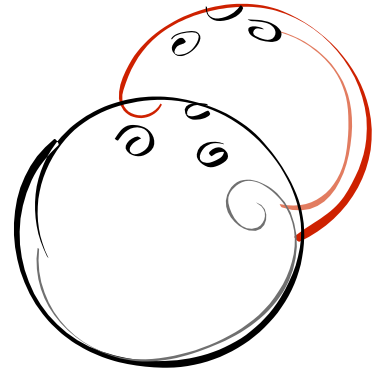

TOURNAMENT RULES

1. This tournament is open to all USBC members in good standing. Members of other associations are welcomed to participate.
2. This tournament will consist of Team, Doubles and Single Events. If signing up for the Singles Event must bowl Doubles Event or vice/versa. Entries will be scheduled as received. Check in 45 minutes before squad time.
3. Entrant must be 18 years or older.
4. **ENTERING AVERAGE** – Entrants must use their highest USBC average from the 2024– 2025 winter season. Entrants without a 2024 – 2025 winter season average will use the highest sanctioned summer league average (2025), minimum 21 games. Entrants with no Winter or Summer 2024-2025 average must use a current sanctioned average of 21 games or more (verifiable). Composite average may be used if no other average is available. **ALL OTHERS MUST BOWL SCRATCH.**
5. **IT SHALL BE THE RESPONSIBILITY OF THE BOWLER TO VERIFY THE ACCURACY OF HIS/HER ENTERING AVERAGE.** Any bowler submitting a false average is subject to disqualification. Any bowler submitting an average that is higher than his/her actual average will use this submitted average. The tournament director reserves the right to re-rate or adjust any entering average.
6. U.S.B.C. ten pin rule is waived.
7. This is a **HANDICAP TOURNAMENT**. The **HANDICAP SHALL BE 90% OF THE DIFFERENCE BETWEEN THE BOWLER'S AVERAGE AND 240.**
8. Prizes will be awarded on a handicap basis only.
Cash prizes awarded on the following ratio:
Team, Doubles, Singles – 1:6
All Events Handicap – 1:10
Prize fund returned 100%.
9. Any protest or error correction must be submitted **IN WRITING** to the tournament director within 24 hours. The tournament committee reserves the right to settle all disputes concerning rules/scoring.
10. **No changes in the order of bowling line up will be permitted.**
11. **ALL U.S.B.C. TOURNAMENT RULES ARE IN EFFECT.**
